- o County Highway 5 Reconstruction
 - Plans are underway and set for a possible letting in June for Asphalting County Highway
 5 (North of Shelbyville to Coon Creek)
- o County Highway 22
 - Completed. Large void under the road, forced us to reconstruct faster than anticipated.
- o County Highway 3 (East of Findlay)
 - Still waiting for programming info from IDOT. The fiscal year for IDOT begins June 1.
- o Prairie Bridge
 - Bridge in Herborn.
 - Estimated start of Next week.
- Oconee Township Bridges 2 Separate Projects
 - Section 19-11120-00-BR, Federal Bridge project.
 - The project is started. Traffic control is currently up, and demolition has started.
 - Section 21-11120-00-BR, Rebuild IL Bridge Project.
 - Project is awarded. Construction will occur after the other bridge.
- o Guardrail Bid Letting
 - Project is moving forward. Looking to start construction next week.
- With a majority of bridge inspections completed. We have seen multiple bridges that are in need of replacement. We have set 5 bridges in motion for reconstruction.
- Multiple 5050s scheduled and multiple completed on time and in budget.
- Other
 - o Highway Department Trainings
 - Safety in Excavation, Confined Space Entry.

 - Michael and Cameron Completed and passed bridge test.
 - o Equipment Wish List from Labor Force.
 - The County Highway Department Is appreciative of the support from the R/B committee and County Board. For the next few months, we do not anticipate any large purchases. But will be focused on maintenance of the roads.
- Bought some smaller purchases and used money made from the sale of the excavator.
 - Resolution for Action for Approval of Engineering Agreement with Civil Design Inc to assist in the structural design, hydraulic study, and all other necessary items for the reconstruction of Structure 087-3195. The estimated cost will be \$38,395 of which Township Bridge (State) will pay 80% of design cost, County Bridge and Township(s) will be responsible to share the remaining 10% each.
 - o Motion made by Clay Hardy, Seconded by Brent Wallace, Passes unanimously.
 - Resolution for action for Approval of Engineering Agreement with Gonzalez Companies, LLC an Engineering group to assist in the engineering, design and all other necessary items for the reconstruction of railroad crossings at roads 1975E, 1900E, 1750N where it intersects with the Union Pacific Rail in Okaw township. The estimated design engineering costs will be \$70,500 total. The construction and engineering cost will be 100% reimbursable by Illinois Commerce Commission post construction.
 - Motion made by Mitchell Shuff, Seconded by Tim Brown, Passes unanimously.

- Petition for 50/50 to construct intersection drainage improvements in PENN Township on County Road 1700W, half mile North of County Highway 21. The estimated cost for the reconstruction will be \$4,992.56 total. Half the cost will be shared at \$2,496.48 each. Michael Tappendorf asked for approval of swapping some of our labor costs for use of the Penn Township equipment. Board Approved.
 - Motion made by Brent Wallace, Seconded by Mitchell Shuff, Passes Unanimously.
- Petition for 50/50 to construct intersection drainage improvements in LAKEWOOD Township on County Road 1650E, just South of 700N. The estimated cost for the reconstruction will be \$8,894.52 Total. Half the cost will be shared at \$4,447.26 each.
 - Motion made by Tim Brown, Seconded by Brent Wallace, Passes Unanimously.
