#### **EMPLOYMENT AGREEMENT FOR COUNTY ENGINEER**

This **EMPLOYMENT AGREEMENT** is made and entered into this 1<sup>st</sup> day of September, 2023, by and between the **COUNTY OF SHELBY, ILLINOIS**, a body politic and corporate (the "County") and **MICHAEL TAPPENDORF** (the "Employee", and together with the County, the "Parties").

In consideration of the mutual promises, covenants and agreements herein contained, intending to be legally bound, the Parties agree as follows:

- 1. Employment The County hereby agrees to employ Employee, and Employee hereby agrees to serve, subject to the provisions of the Agreement, as an employee of the County in the position of County Engineer of the County of Shelby. Employee will perform all services reasonably necessary to fulfill the duties and responsibilities of the position of County Engineer as described in the Illinois Highway Code (605 ILCS 5) including but not limited to, the following:
  - a. Act for the County in all matters relating to the supervision of the construction or maintenance of any highway constructed or maintained in whole or in part at the expense of the County.
  - b. Prepare or cause to be prepared, plans, specifications, and estimates of costs needed to comply with the provisions of the Illinois Compiled Statutes.
  - c. Present petitions, resolutions, agreements, and budgets to the County board for approval.
  - d. Advise and direct the 24 highway commissioners as the best methods of construction, repair, or maintenance of township and district roads.
  - e. Manage the budgeting and financial management of the Township Motor Fuel Tax program, County Motor Fuel Tax program, and local funded programs (County Highway, County Bridge and FASM)
  - f. Address all applicable questions and findings from audits of the highway Department financial fund account/ bookkeeping, bridge inspection program, and construction projects.
  - g. Perform all requirements as Program Manager of the National Bridge Inspection Standards (NBIS) program.
  - h. Generate and submit multi-year capital program to Road & Bridge Committee and IDOT.
  - i. Supervise the construction and maintenance of all county highways within the county.

- j. Keep and maintain adequate records and books of all recipients, contracts, purchases of materials, machinery, or apparatus.
- k. Supervise all Highway Department staff.
- I. Perform other lawful duties as may be prescribed by law or as may be required or directed by the majority of the Shelby County Board.
- m. Maintain any and all qualifications, certificates and/or licenses as are necessary to fulfill duties and receive any and all additional training or education as is required.
- n. Prepare Grant applications for additional funding and administer projects to grant requirements.
- 2. **Term** The Term of this Agreement shall be for a period of six (6) years beginning on SEPTEMBER 1<sup>st</sup> 2023 and running through AUGUST 31<sup>ST</sup> 2029 provided, however, this agreement shall terminate prior to AUGUST 31<sup>ST</sup> 2029 upon the occurrence of any of the following:
  - (a) Resignation of the Employee; or
  - (b) Termination of this Agreement by agreement of the Parties; or
  - (c) Removal of County Engineer pursuant to 605 ILCS 5/5-203 for incompetence, neglect of duty, or malfeasance in office.
- 3. Salary and Benefits The Employee shall be paid an annual salary as follows:

Beginning SEPTEMBER 1<sup>st</sup> 2023, the Employee shall be paid an annual salary of \$130,000 (IDOT minimum base is \$116,500 for CY 2023). The salary shall be adjusted on January 1st of 2025 and every January thereafter and the salary shall always be 12% above IDOT's Minimum County Engineer Salary Program for Shelby County. Said salary is to be paid in equal installments upon the same terms as other Shelby County employees.

Employee shall receive all insurance benefits, Social Security benefits, IMRF and all other benefits as are provided for full-time County employees.

#### 4. SIGN-ON BONUS -

A 30,000 dollar sign-on bonus will be given to the County Engineer in the following manner: (the exact terms that the sign-on bonus is to be paid out is according to previous board action in May and June of 2023). This sign-on bonus is to be financed by ARPA funds.

Week one: \$7,500 6 Month: \$15,000 1 year: \$7,500

#### 5. RETENTION BONUS -

A \$15,000 dollar RETENTION bonus will be given to the County Engineer in the following manner: \$5,000 per year for three (3) years to be paid on the anniversary day of employment. The 1st year anniversary retention bonus is 5K. The 2nd year anniversary retention bonus is 5K. The 3rd year anniversary retention bonus is 5K. This retention bonus is to be financed by ARPA funds.

1 year: \$5,000 2 year: \$5,000 3 year: \$5,000

#### 6. **PAID TIME OFF** – Paid time off shall accrue as follows:

- (a) Five (5) days of Paid vacation shall be awarded upon employment on September 1st, 2023
  - On January 1st, 2024, Fifteen (15) days of Paid vacation shall be awarded and each January 1st thereafter at an accrual rate of 10 hours per month.
  - On January 1<sup>st</sup> of 2029, rate shall increase to Twenty (20) days of Paid vacation each calendar year at an accrual rate of 13.33 hours per month thereafter.
- (b) Twelve (12) sick days each fiscal year at an accrual rate of 8 hours per month, to be awarded eight hours on the first day of each month. Sick days will carry over from year to year if not used.
- (c) Three (3) Personal Days to be accredited at the beginning of contract (Sept 1, 2023) and beginning of each Calendar Year thereafter (January 1 of each year).

A Maximum of (20) unused vacation days may be carried over each calendar year. All other vacation time unused at the end of the calendar year shall be forfeited. Employee shall receive holidays as are provided for other full-time County Employees. Unused Personal Days shall be forfeited at the end of the year (December 31 of each year) with no carry over allowed.

- 7. HOURS OF EMPLOYMENT Employee shall be required to devote a sufficient number of hours per week on or off site to satisfactorily perform the duties described herein. Employee shall work, or otherwise account for a minimum of (40) hours per week, with additional hours as required. Employee shall not, during the term of this Agreement, or any extension thereof, participate or be interested directly or indirectly, or in any manner, in any other business or activity similar to the obligations of the Employee as set forth in this Agreement, without the prior express approval of the County. Employee is considered a salaried, not an hourly, employee.
- 8. SHELBY COUNTY HIGHWAY DEPARTMENT EMPLOYEES Upon the hiring of new Shelby County Highway Employees, the employees shall meet the expectations and approval of BOTH the Shelby County Engineer and Shelby County Roads and Bridges Committee.

- **9. EQUIPMENT AND PERSONNEL** The County shall provide for the Shelby County Highway Department all equipment and personnel reasonably required as determined by the County, consistent with the financial condition of the County and upon consultation with the Employee.
- 10. COUNTY BOARD MEETINGS Employee shall attend meetings set by the Shelby County Roads and Bridges Committee as scheduled and requested by the County Board and provide the County Board with any requested information and reports. If the Employee shall be unable to attend the meeting, a report will be prepared and provided to the County Board for presentation by the Shelby County Roads and Bridges Committee Chairman or another authorized individual.
- 11. TRANSPORTATION AND VEHICLE A late model automobile of a make and model mutually acceptable to the County and Employee shall be provided by the County for the exclusive use of the County Engineer for business use, including the taking of the vehicle home and back each day to allow for required hours use.
- 12. DUES The County shall pay all dues and fees associated with the Employee being a member of the Illinois Association of County Engineers and any other organization or association deemed necessary by the County Board for the proper and effective performance of his duties associated with the office of the County Engineer. The County shall pay all fees associated with licenses required by the County Engineer for the performance of his duties.
- 13. EXPENSES The Employee shall be reimbursed by the County for his actual traveling and other expenses incurred in the discharge of his duties of his office, including but not limited to cost of all meals, lodging, transportation and registration fees for seminars, classes and conferences related to County Highway Department work and operations. All expenses shall be verified with paid receipts. The County will reimburse the Employee for all fees associated for PDH hours required to maintain an Illinois Professional Engineer License.
- 14. LEGAL FEES- All expenses incurred by the County Engineer in prosecuting or defending suits or actions brought by or against him in any official capacity shall be paid by the County. Any judgments levied against the County Engineer incurred due to the performance of his official duties shall be paid by the County.
- **15. AMENDMENTS** The terms of this contract may be modified, altered, or amended only upon the written agreement of the parties of this contract.
- **16. SEVERABILITY** The provisions of this contract are severable. Should any sentence, paragraph, or section be held contrary to law, for whatever reason, such decision shall not affect the remaining portions of the contract.

17. **TERMINATION OF CONTRACT** – This contract may be terminated by the County in accordance with the Illinois Compiled statutes (605 ILCS 5/5-203) or by the Employee with sixty (60) days written notice of such termination.

The parties have read this contract and understood it to be their entire agreement and that this contract supersedes all oral negotiation and agreements between the parties. Any altercations, amendments, or modifications, or waivers or any provision of this contract shall be valid only when expressed in writing and duly signed by the parties.

#### Shelby County Illinois Whistleblower Policy

This policy is pursuant to 740 ILCS 174, The Whistleblower Act. A whistleblower as defined by this policy is an employee, volunteer, appointed or elected official of Shelby County who reports an activity that the person considers to be illegal or dishonest to one or more of the parties specified in this policy. The whistleblower is not responsible for investigating the activity or for determining fault or corrective measures; appropriate management officials are charged with these responsibilities.

Examples of illegal or dishonest activities are violations of federal, state or local laws and other fraudulent financial reporting.

If an employee, volunteer, appointed or elected official of Shelby County has knowledge of or a concern of illegal or dishonest fraudulent activity, the person is to contact his/her immediate supervisor or the State's Attorney. The person must exercise sound judgment to avoid baseless allegations. Any person who intentionally files a false report of wrongdoing will be subject to discipline.

Whistleblower protections are provided in two important areas -- confidentiality and against retaliation. Insofar as possible, the confidentiality of the whistleblower will be maintained. However, identity may have to be disclosed to conduct a thorough investigation, to comply with the law and to provide accused individuals their legal rights of defense. Shelby County will not retaliate against a whistleblower. This includes, but is not limited to, protection from retaliation in the form of an adverse employment action such as termination, compensation decreases, or poor work assignments and threats of physical harm. Any whistleblower who believes they are being retaliated against must contact the State's Attorney immediately. The right of a whistleblower for protection against retaliation does not include immunity for any personal wrongdoing that is alleged and investigated.

All reports of illegal and dishonest activities will be promptly submitted to the State's Attorney who is responsible for investigating and coordinating corrective action.

Employees, volunteers, appointed or elected officials with any questions regarding this policy should contact the State's Attorney.

This letter serves as a letter of engagement for our services related to the Management of I.T. Infrastructure and review of reports. Mytec Solutions, Inc. will provide the following services to Shelby County (referred to in this agreement as the "Customer").

#### **Scope of Work:**

Mytec Managed Services as outlined in the Mytec Complete Care Service Details document and Service Level Agreement.

#### Fees:

Managed Services Monthly per outline

\$ 4,000.00

#### **Billing:**

- Monthly fees are due and payable by the 15th of each month in advance.
- Monthly invoices will be automatically generated by the ticketing system and emailed on the 25th of each month beginning August 25th, 2022.
- Additional work outside the managed services agreement and over the contracted amount for additional labor will be invoiced as completed and paid next payment cycle.

All requests for assistance will be completed using Mytec Solutions ticketing software, by email, or telephone. All requests received for additional work or assistance outside the scope will be entered into the ticketing software and e-mailed to requesting party for approval before work proceeds. Emergency work is exempt from this process but will require approval as soon as possible. This system allows both parties to monitor progress

of work, track time used, and identify repetitive issues that may require further investigation or additional time to complete the work.

Notification of any events or anomalies identified by this work will be reported to Shelby County's I.T support staff for authorization of work to be completed to correct the issue before work is completed unless it is determined by consultant to be an emergency. Emergency work will be completed and reported as soon as possible.

All work is to be completed during normal business hours (7:30am to 5:30 pm) which could mean minimal interruption of the network. Advance notices will be given (if possible) should this happen.

All after hours and emergency response time will be same day if notified before noon or next business day morning if notified after noon.

While every attempt will be made to stay within the time and cost estimated, unforeseen complications or changes in the scope of the engagement might increase our fees and expenses. The need and reason for additional fees and expenses will be communicated to management for approval before said time and costs are incurred (if possible).

#### **Provisions**

The Customer shall provide Mytec Solutions access to the network resources as well as login accounts and passwords as needed to complete the above stated items. Additionally, the Customer grants Mytec Solutions permission to test the IP addresses, equipment, and resources needed to complete the defined scope.

This letter with addendums constitutes the entire agreement regarding the services we will provide and supersedes all prior agreements, understandings, negotiations, and discussions between us, whether written or oral. This agreement may be supplemented only by other written agreements. This is a 3-month agreement starting September 1, 2022 to align with the new fiscal year policy. Either party may terminate the contract at any time with a 30-day written notice and without penalty except for third party software that is purchased with a 1-year commitment.

Mytec Solutions shall provide an annual certificate of insurance, disaster recovery plan and information security program within reason to demonstrate their preparedness for unforeseen events. These documents may be provided to the Customer's regulatory agency if requested. Failure to provide these statements may result in termination of services.

Mytec Solutions will discuss monthly support provided to the Customer that falls outside the maintenance agreement to help the Customer's IT department understand recurring issues that can be resolved internally.

It is our understanding that the primary intent of engaging our professional services is for the benefit of the staff and management of Shelby County. Our services are not intended to benefit or influence any other person or entity. Any reports that we may prepare will indicate that they are for limited distribution to only management personnel of the Customer and their regulatory agency if requested.

If a bill for services is not paid within 45 days from receipt of invoice, we reserve the right to cease work and withdraw from the engagement. In that event, we will charge interest on the unpaid balance at the monthly rate of 11/2%, which is an ANNUAL PERCENTAGE RATE OF 18%. In the event that any collection action is required to collect unpaid balances due us, reasonable attorney fees and expenses shall be recovered. Our maximum liability relating to breach of this contract (regardless of form of action, whether in contract, negligence or otherwise) shall be limited to the amount of the contract giving rise to liability. In no event shall we be liable for, special, incidental or punitive loss, damage or expense (including without limitation, lost profits, opportunity costs, etc.) even if we have been advised of their possible existence.

The Customer shall indemnify and hold us, and our personnel, harmless from and against any claims, liabilities, costs and expenses (including without limitation, attorneys' fees and the time involved of our personnel) brought against, paid or incurred by us at any time and in any way arising out of actions or failure to act, except to the extent of gross negligence or willful misconduct of our personnel. This provision shall survive the termination of this agreement for any reasons.

Protection of Customer Data: All data relating to Shelby County business provided to Mytec Solutions, Inc. (Mytec Solutions) by the Customer, including any non-public personal information relating to customers of Shelby County, shall be treated confidentially and safeguarded by Mytec Solutions.
