Mr. Rushing would like to build a 24' X 28' garage on this parcel, but the setbacks are too narrow because it is zoned as agriculture. The setbacks for side yard lines for agriculture are 20 feet. This lot is only 50 feet wide. The parcels immediately to his East are zoned as R1, single family residence, and he would like his setbacks to be the same. Side yard setbacks for R1 zoned lots are 6 feet.
